## You Need to Know:

- Auction opens at 12:00 noon CST on Monday, February 9, 2015.
- Auction closes at 12:00 pm (noon) CST on Friday, February 27, 2015.
- The minimum bid increment is \$1.00.
- All items are sold 'as is'.
- Winning bidders must make arrangements to pay for their item before March 13, 2015 or the item will be given to the next highest bidder.
- Winning bidders are responsible for picking up their item or paying postage/shipping for its delivery.
- All proceeds from the Calling Lakes Centre Online Auction will go to Calling Lakes Centre and once the debt is paid off, other groups will benefit.

## Please read the rules carefully

### 1. To participate, you must register. To register:

- a. "join" the Calling Lakes Centre Online Auction Facebook group
- b. contact Calling Lakes Centre office at 306-332-5691 to register and bid by phone
- c. You must be 18 years or older to bid. Youth under 18 years of age must have parental consent to bid. The auction is limited to Canadian residents.

### 2. To place a bid:

- a. Comment your bid amount directly on the item's Photo Page.
  - i. Please be aware that if you are posting/bidding on someone else's behalf you will assume their responsibilities outlined below if the item is won.
- b. Phone Calling Lakes Centre Office at 306-332-5691 to place a bid by phone. The Office Staff will place a bid on the Facebook page on your behalf.

### 3. By bidding, you are stating that you are ready and willing to purchase that item for your bid amount.

- a. It is your responsibility to read the description of the item and understand the item you are bidding on.
  - b. You are entering a contract to buy the item, and to deliver payment within the time period specified.
  - c. Your bids are final and non-retractable.**
4. Non-conforming bids will NOT be accepted and will be removed.
  - a. Bidding must be done in **increments of at least \$1.00** (no cents!).
5. Non-conforming bidders will be removed from the group and barred from re-entry.
  - a. Non-conforming behaviour includes but is not limited to, harassing other bidders, retracting bids, and 'spamming' the group page or item comment section with unrelated comments.
6. Items may be added to or removed from the auction at any time for any reason deemed appropriate by the Calling Lakes Centre staff.
- 7. The last and highest bid registered at 12:00 pm (noon) CST on Friday, February 27, 2015 constitutes the winning bid.** Bids received at 12:01 pm CST or later will not be accepted.
- 8. All Online Auction Item Winners will be notified by email, phone, or on Facebook after the auction closes to make payment/pick-up arrangements.**
  - a. Calling Lakes Centre Staff will contact you directly for payment and shipping details. Please protect your privacy and do NOT post any personal information (address, financial payment information) on Facebook. Be wary of anyone requesting your personal information through Facebook and report any user you deem suspicious.
9. All items will be available for pick up from Calling Lakes Centre.
  - a. Payments can be made through the Calling Lakes Centre Office by cheque, cash, Visa or MasterCard. Cheques can be made payable to the "Calling Lakes Centre".
  - b. Items will not be shipped/available for pick-up until they have been paid for.
  - c. Sales receipts can be provided if requested.
  - d. If Online Auction items are not paid for by Friday, **March 13, 2015**, the item will be considered unclaimed and the next highest bidder will be contacted.
10. If you need an item shipped, it is your responsibility to pay for shipping. If you do not make arrangements to pick up the item, or pay for shipping by March 13, 2015, the next bidder will be notified.
11. All sales are final and all items are sold "as is". Measurements are approximate.
12. Liability and Responsibility
  - a. In the event of a dispute, Calling Lakes Centre Closing Work Group will act as the final authority.
  - b. Calling Lakes Centre assumes no risk, liability or responsibility for any item.
